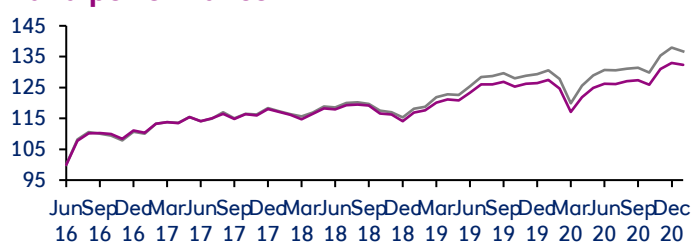

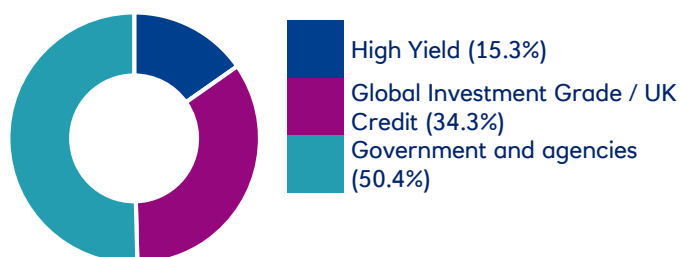

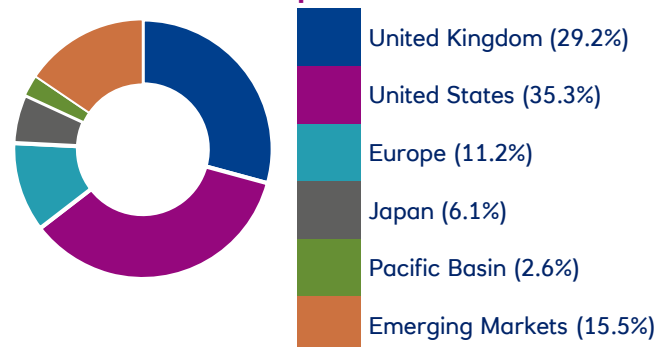

## Asset breakdown – Bonds



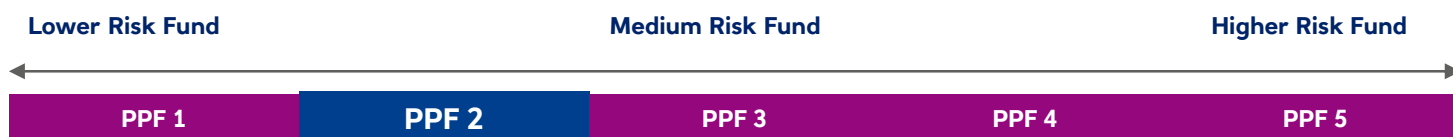
